REINSTATEMENT OF COLLABORATION AGREEMENT

THIS REINSTATEMENT AGREEMENT dated

7th May

2019 is made

BETWEEN:

- (1) THE UNIVERSITY OF LEEDS, a higher education institution incorporated by Royal Charter under number RC000658 whose registered address is at Leeds, LS2 9JT ("Leeds"); and
- (2) INSTITUTO DE INVESTIGACIONES DE LA AMAZONÍA PERUANA, RUC Nº 20171781648, whose administrative offices are at Avenida José A. Quiñones km. 2.5, Apartado Postal 784, Iquitos, Perú, duly represented by its president Dr. LUIS EXEQUIEL CAMPOS BACA ("IIAP"),

hereinafter referred to as the "Parties" (and each of them being a "Party").

WHEREAS

- (A) The Parties have been collaborating on a research project entitled "Ensuring that the impact of climate change on species, Protected Areas (PAs) and the PA Network in the Peruvian Andes Amazon region is effectively incorporated into management decisions" (the "Project") with financial support from The Gordon & Betty Moore Foundation (the "Funding Body") under the terms of a collaboration agreement dated 13th January 2017, a copy of which is annexed hereto as Appendix A (the "Primary Agreement").
- (B) The Parties acknowledge that the Primary Agreement expired on 31st December 2018.
- (C) Due to the need to continue the achievement of the Project, the Funder has agreed a no-cost extension, and the Parties now wish to reinstate the Primary Agreement on the same terms, and effective from the effective date as if it had not expired, with the following amendments:

IT IS NOW AGREED:

- 1. This Reinstatement Agreement shall have an effective date of the date of this Agreement (the "Effective Date").
- 2. Unless otherwise stated, defined terms used in the Primary Agreement will carry the same meanings in this Reinstatement Agreement.
- 3. As from the Effective Date, the Parties hereby agree that the "Project Period" as defined at clause 1.1 shall be amended as follows:
