OBJECT OF THE MoU

- 1.1 The object of the MoU is to facilitate a progressively closer working relationship between Universidad Nacional de la Amazonia Peruana (Facultad de Ciencias Forestales), University of Tartu (Ecology and Earth Sciences), and Instituto de Investigaciones de la Amazonía Peruana (Programa de investigación BOSQUES) through the development of educational and scientific co-operation in the field of global change studies.
- 1.2 To achieve the object above, the MoU is to enable the parties, from time to time, to negotiate and conclude agreements, subject availability of funds, either from internal or external sources, dealing with, *inter alia*, the following:

- 1.2.1 the exchange of staff members for the purpose of research, teaching and the presentation of and/or participation in special courses;
- 1.2.2 the joint supervision of PhD students within the mutual scientific cooperation;
- 1.2.3 the development of joint research projects of mutual interest;
- 1.2.4 the publication of scientific papers and textbooks resulting from co-operative projects;
- 1.2.5 the organisation of conferences, seminars, symposia and (international) courses of mutual interest to the parties.

2. DURATION AND TERMINATION

- 2.1 This agreement shall commence on the date of the last signature of MoU and is agreed for 3-year period.
- 2.2 This MoU may be terminated by either party at any time by giving to the other not less than 30 (thirty) days written notice.

3. AUTHORITY

The parties hereby warrant and represent that they are authorised to negotiate, conclude and implement this MoU.
